Please Read the Trip Guidelines for Financial Assistance

- One application per girl per membership year.
- Girl Scouts of Greater Iowa will offer individual girl financial assistance based on documented financial need and confirmed membership registration.
- Recommendations for financial assistance are made by a committee of volunteers and program staff.
- Applicant(s) must be registered for Trip for which assistance is requested.
- Preference will be given to applicants who have participated in council-wide product sales programs and have raised an appropriate percentage of their fees through product sales and other efforts.
- Financial Assistance application deadline is two months prior to final payment date for trip fees.
- Allow a minimum of 30 days for the processing of the application.
- Girl Scouts of Greater Iowa may apply for individual girl assistance as often as need exists, however, priority is given to first time requests.
- Future assistance may be declined for those recipients who, after receiving notification, fail to attend the council Trip, activity or event for which assistance was rewarded, without notification to the Girl Scouts of Greater Iowa.
- WITHOUT COMPLETE INFORMATION, THE APPLICATION WILL NOT BE CONSIDERED.
- Awards are determined by need and availability of funds.
- All information is completely confidential.
- All families must pay some portion of the Trip fee based on the ability to pay.
- **By accepting Financial Assistance for a Trip, the girl and her family will agree to:
Make two (2) presentations for an International Destination or a National Destination publicized through GSUSA. The presentations will be to ONE GIRL SCOUT TROOP and to ONE COMMUNITY/CHURCH/SCHOOL or other GIRL SCOUT GROUP.**
